NOTIFICATION

In exercise of the powers conferred under Section 162(1) of the Electricity Act-2003 & Regulation No.34 of Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations 2023, and in view of the recommendation at Sl. No. 75 of the Business Reform Action Plan (BRAP-2024), the Governor of Tripura is pleased to notify the following procedure of obtaining approval for Diesel Generator (DG) set installation (Registration and Renewal) meant for commercial and industrial purposes from the Electrical Inspectorate:

- 1. To provide time bound service in obtaining Electrical Safety Recommendations and Electrical Safety Clearance Certificate for industries, commercial establishments and businesses, and to maintain transparency and accountability on the part of the officials of Electrical Inspectorate, Power Department, Government of Tripura, the entire workflow / process of approval for DG set installation for industries, commercial establishments and business shall be dealt online only through the single window online SWAAGAT portal. The Electrical Safety Recommendation and Electrical Safety Certificate downloaded from SWAAGAT portal will be valid across the state of Tripura. No offline applications shall be accepted.
- 2. Information on fees, procedure, timeline for issue of certificates etc. and a comprehensive list of all documents required for getting Fitness certificate for installation and charging of different capacity of DG Scts from Electrical Inspectorate shall be available in SWAAGAT portal.
- 3. Submission of application, payment of application fee, tracking status of application and downloading of the final signed certificate shall be through online without requirement of physical visit to the department.
- 4. No physical / manual application shall be required to be submitted to the Electrical Inspector in addition to the online application.
- 5. No physical copies of documents which were uploaded by the applicant at the time of submission of online application in SWAAGAT portal shall be required by the Electrical Inspector. However, the applicant shall produce authentic copies of the required documents on demand by the Electrical Inspector during inspection / site visit.
- 6. The application shall be disposed off within the stipulated timeline.
- 7. The Electrical Inspector shall accept digitally signed certificates downloaded from the SWAAGAT portal as valid and shall not require physically signed / stamped certificates.
- 8. The applicant shall not be required to meet the Electrical Inspector in person except in cases where inspection / site visit is mandated by law.
- 9. The validity of fitness certificate for charging all types of DG sets shall not exceed five years.
- 10. Renewal of different capacity of DG sets will also be done through online system in SWAAGAT portal.
